Blackfish presents mostly just one side of a debate over whether it is right for killer whales to live in captivity. Now that we have an understanding of some of the ideas presented in the award-winning documentary, we will learn more and try to better understand the issue from both sides. We will try to gain an understanding from the perspective of SeaWorld and others who may not agree with the film's claim, as well access a few more sites that provide related information.
